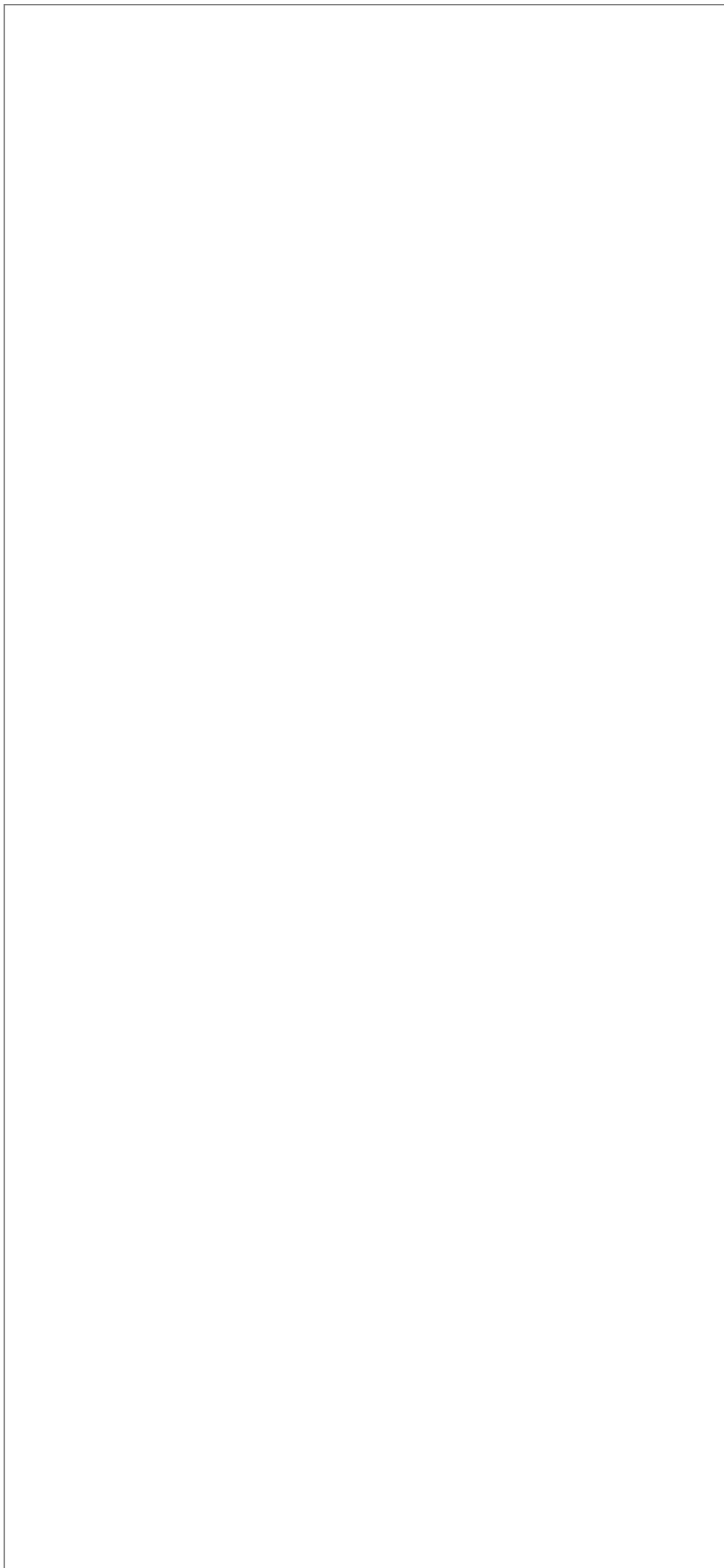

Intensive training for all teachers on the implementation and best practices of the Eureka Math Program, new ELA Curriculum and the Science of Reading (LETRS training).

NEE resource for teacher evaluation ensures that tier 1 instruction is meeting the needs of all students and providing adequate differentiation, scaffolding and appropriate enrichment opportunities in the general education and intervention-based classroom spaces.
