Performance Matters resource for teacher evaluation ensures that tier 1 instruction is meeting the needs of all students and providing adequate differentiation, scaffolding and appropriate enrichment opportunities in the general education and intervention-based classroom spaces.

Our preschoolers participate in our specials classes to prepare them for the transition to Kindergarten.
