READ 180 and Systems 44 will support students with extra learning time beyond the core curriculum to fill reading proficiency gaps providing them a better chance of maintaining the rigor of the 6th grade content standards.
*Chromebooks - one to one devices to provide computer based instruction to learners using 7 mindsets social emotional curriculum, and MySci science curriculum.
*Site based social worker-to support the health and social emotional needs of students (particularly in the virtual setting) to allow students to access the MLS curriculum. Provide wrap around services to students/families. Support transition to "in-person' school when approved.
